The following must accompany your child's admission form - without these documents he/she will not be accepted at De Aar High School.

A **certified copy** of your municipal account (proof of address-NOT OLDER THAN 3 MONTHS) - It must be the account of the parent/guardian that will be liable for the child's school fees.

A **certified copy** of the child's latest report card.

A **certified copy** of the child's birth certificate.

A **certified copy** of the child's December 2015 report card must be handed in on the **first** school day of 2016.

A **certified copy** of proof of identification of any person falling under the definition of "parent" under the School's Act that is approved of by the School Governing Body, must be provided.

Any person who enters a learner **MUST**, however, conform to the following regulations, and the necessary documentation must be sent to the school urgently.

A BIOLOGICAL PARENTS

Definition: Learners who stay with the biological parents.

Both biological parents' identity document must be attached. A certified copy of the death certificate of a deceased biological parent must be attached.

B LEGAL GUARDIANS

Definition: Legal guardianship of the child must be conferred by a court. A certified copy of any court order, any claim for legal guardianship, or any similar right of the person ("parent") must be provided.

C OTHER

The category "OTHER" may be sensitive and we apologise in advance, but unfortunately it is what the regulations imply.

Definition: Learners who do NOT live with their biological parents / legal guardians as defined by A and B.

Should a learner live with a person who fulfils the role/function of a parent, the following documentation must be handed in:

The certified copies of the death certificate of both biological parents as well as a sworn affidavit that confirms that the learner stays with guardians who fulfil the role of parents. This data must also reflect on the school's system as checked by you.

All the above categories are then also responsible for the learner's school fees and ALL school fee documentation must adhere to category A, B or C.
